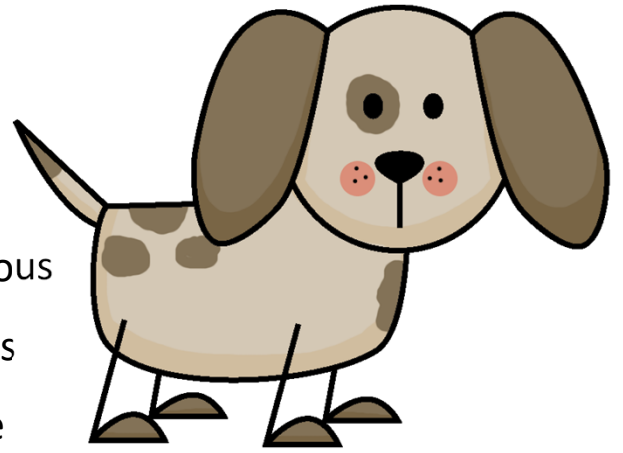


# Tucker
